# Regional facilitator Role description

The Blagrave Trust is seeking a creative and dynamic facilitator to support the development of a new regional advisory panel.

The regional advisers are an intergenerational team of people with experiences of accessing and working in youth services in the SE Region, who will be employed to guide Blagrave's grant-making in the region.

Location: We are looking for someone who lives or works in the SE of England (specifically Berkshire, Hampshire and the IOW, Sussex or Wiltshire or neighbouring counties excluding London)

Contract length:

1 July 2024 - 30 September 2025.

Salary: Day rate £350 per day, up to a agreed maximum number of days.

Closing: 31 May 2024

Interview Tues 18 June (in person, in London)

**Overall Purpose:** To support Blagrave regional advisers to evaluate funding requests and make recommendations on funding for youth organisations.

### **About Blagrave**

Blagrave is an independent charity dedicated to serving young people who are challenging and experiencing injustice in their individual lives and within society. We hold investments of c. £44 million, which along with other income sources, funds all the work we do including grant-making. We fund young people directly on a national basis through our Challenge and Change and Pathways funds. Through our place based funding, we provide small grants (usually between £20,000 - £30,000 per annum) to grassroots organisations serving the urgent needs of young people facing injustice, in Berkshire, Hampshire and the Isle of Wight, Sussex and Wiltshire.

We are committed to centring the voices of those we seek to serve and aim to do this in a variety of ways. This means that our board and staff team have relevant lived and learnt experiences to help us fulfil our mission. We are committed to listening to the communities we seek to serve both directly and broadly to have as accurate of an understanding as possible about the issues that those we're here to serve are facing.

### **Regional funding**

The aim of our regional fund is to enable youth organisations to meet the needs of young people who experience social injustice in the region.

Each year, we allocate at least £300,000 in new funding to youth charities in Berkshire, Hampshire, Sussex and Wiltshire. We are creating the role of regional advisers as part of our strategic goal to share power with the communities we seek to serve.

We believe no one knows better about where funding should go in the region than the local youth sector. We think the combination of our grant making knowledge with local



expertise is essential to make the best possible decisions on how our resources can best reach the young people we seek to serve.

The most powerful conversations contain; lived, learned and practiced experience and so we want to build an intergenerational panel, made up of those who have a stake in the local youth sector. That's why we are looking to form a group of 8-10 people who have worked in the youth sector as a volunteer, staff member or Trustee in the last 12 months or have accessed and benefited from these services as a young person.

### About the role

To support the advisers, Blagrave is looking to appoint a skilled facilitator in the region.

You will play a key role in supporting our advisers to do their work by building individual relationships, supporting the formation of the group and creating a safe and productive space where everyone is able to meaningfully contribute. You will support the recruitment and the induction of the advisers, and will be responsible for planning and running regular meetings, both in person and online, and including an away day including an overnight stay.

### Essential criteria

You will be:

- Based in the South East of England (Berkshire, Hampshire & IOW, Sussex or Wiltshire or neighbouring counties not London)
- A skilled and experienced facilitator of groups, particularly those where difficult or sensitive decisions need to be made
- Experienced in working with intergenerational groups including experience working with young people
- Knowledgeable of the context for charitable funders
- Comfortable supporting people from all walks of life to work together
- Able to work with uncertainty and respond flexibly to emerging issues
- Thorough and diligent in your approach

And you will have:

- A love of creative methods for having meaningful, fun and energising conversations
- An awareness of how power and privilege play out in group conversations and a commitment to help the group work together – with an awareness of your own power in the group
- An ability to create a safe, warm atmosphere where people can relate as people, not just in their assigned roles



- A willingness to support honest conversations and disagreement; recognising that surfacing and dealing with difficult issues openly and with kindness can help deepen trust
- A knowledge of different decision-making methods for the group to experiment with

As we consciously recruit a diverse group of advisers, it is essential that you are skilled enough to hold space for everyone despite their differences in experience of charity services, allowing for differences of opinion and a variety of experiences of social injustice.

We are open to candidates from all backgrounds, but we will prioritise those who will help us to continue to diversify the voices heard in philanthropic work and in particular centring young people in all we do. We are committed to creating an equitable environment where all can thrive.

### Geography

The advisers will be drawn from across the South East of England and we anticipate that meetings will be a mixture of online and in-person according to practicality. In person meetings will be important occasions, with meetings in a convenient location (eg Winchester or Southampton most likely).

### Key tasks

The facilitator's role will be to support the Advisers to play equal and cohesive parts in grant making decisions over the course of the coming year.

Following a thorough period of induction, the advisers' work will involve monthly meeting online where they will be:

- Assessing initial requests for funding from organisations to advise on which should go forward
- Reading Blagrave's assessments, debating the merits of different applications and ultimately recommending funding decisions to our CEO or Trustees (who retain sign off and accountability)
- Providing feedback on effectiveness and impact of our funding following visits to charity partners.

Consultation and feedback

- Provide a sounding board for Blagrave's wider strategy in the region
- Refining criteria for Blagrave funding in the region

### Terms

The role will be on a self-employed basis, so you will invoice Blagrave based on time spent up to an agreed maximum. The daily rate is £350 including VAT. Any travel or expenses costs will be reimbursed separately.

# Time frame and time commitments

This agreement runs from 1 July until 30 September 2025. The advisers will begin in August 2024 and they will be employed for a year. Your time commitment will vary with the demands of the work. At some points, we anticipate weekly meetings; at other points meetings might be monthly.

Based on our experience with other programmes, we anticipate the role will need around 4-6 X days per month to include administration time. We have budgeted for up to 28 days of your time in calendar year 2024 and we anticipate similar in 2025.



To accommodate advisers' other commitments, we expect meetings will take place at evenings or weekends.

## **Safeguarding and Equity Statement**

The Blagrave Trust is committed to safeguarding children and adults at risk, to promoting the welfare of adults, and keeping all those who come into contact with our work safe from harm.
