



## **Invitation for Expressions of Interest: Provider(s) for Peer Learning & Support offer to Regional Programme Partners**

### **1. Background**

Blagrove is an independent funder dedicated to serving young people who are challenging and experiencing injustice in their individual lives and within society. As part of this, our Regional Programme gives funding to over 40 youth focused partners across Sussex, Wiltshire, Berkshire, Hampshire and the Isle of Wight. Although the programme closed to new applicants in September 2025, all partners have a commitment to funding from Blagrove for 3 years, a small number of whom are on their second or third tenure.

Alongside financial support, and in response to ongoing insight from our partners, we are seeking to enhance our offer of peer learning and support opportunities for those in the programme.

### **2. Purpose**

We are inviting Expressions of Interest to develop and deliver Blagrove's Regional Programme support offer for youth organisations (charities and CICs) in the SE of England. To accommodate the diversity of partners and encourage specialist expertise, we are offering a three-pronged opportunity, open to individual professional(s), organisations, and/or collaborations who can deliver one or more of the learning strands outlined below.

In alignment with [our commitments](#) we are seeking a provider(s) to build on our existing peer learning group for Regional partners in the South East; to support their expertise on youth leadership, engagement and service delivery. In response to feedback from partners and need for specialist input, we want to extend this offer to include optional bespoke support on safeguarding, and fundraising/income generation.

We are therefore seeking EOIs from individual professional(s), organisations and/or collaborations who are:

- Confident organizing and optimizing learning opportunities for audiences with a diverse range of lived, learnt and professional experiences;
- Experienced supporting youth organisations' development and growth, with recognition of on-going challenges and constraints;
- Flexible in accommodating the learning priorities of partners, being both proportionate and responsive to needs;
- Proven ability to unlock potential in participants, through peer-learning, reflection exercises and/or workshops;
- Innovative in their approach to delivering organisational support, insight and development opportunities;
- Holds specialist expertise in youth leadership and engagement, safeguarding and/or fundraising, able to evidence this through previous experience, qualification and/or accreditation;
- Able to demonstrate strong administrative and communication skills;
- Experienced in accommodating varying access needs, accommodations, and learning styles, working alongside Blagrove to enable equitable participation;
